Winter Park Spring Trip 2012

Travel, Financial, and Personal Responsibility Agreement/Trip Contract

This letter of agreement is between _____ (student) and the Red Oak HS Band. This is our commitment to participate in the band spring trip which will be to Winter Park, Colorado during the dates of March 29 - April 3, 2012.

Parents, please READ and INITIAL your acceptance after each item. These conditions are vital to the success of the trip!

_____ I will help my child maintain their academic studies to help *ensure* that they retain their academic eligibility under the rules/laws of the state of Texas (i.e.—no pass, no play).

_____ I accept full responsibility for the actions of my child while on the trip. This includes any bus/room/condodamages. If any charges are incurred as a result of my child's actions, I understand I must pay for them.

_____ I agree that my child will abide FULLY with all required rules and guidelines set forth on the trip by the band staff. I understand that failure to comply with any rules may result in disciplinary action deemed appropriate by the band staff, Red Oak HS administration, or the ROISD.

_____ I am fully aware that there is a ZERO-TOLERANCE policy for the following: shoplifting, vandalism, drug/alcohol/tobacco use, violation of the "threshold rule" (no guys in girls rooms and vice versa), and leaving rooms after curfew. I understand that these are "send home" offenses (parent expense), and that further legal or ISD action may follow. I further understand that this is not necessarily a comprehensive list—a determination on the seriousness of the offense would be made by the band staff in consultation with a Red Oak administrator.

_____ I understand the cost of the trip to be \$600, which is inclusive except for the cost of lunch each day, fast-food meals while on the bus trip, and any desired personal expenses (souvenirs, etc.).

_____ I understand that the initial deposit is \$75, that it is due with this signed agreement on Thursday, October 27th, and that *the initial deposit is NON-REFUNDABLE*. (initial deposit may come from your current Charms account if at least \$75 is already there)

_____ Trip cancellations *may* be made if absolutely necessary, subject to the following provisions: (a) the deposit is non-refundable, (b) NO refunds will be made after the last payment date of February 8th, 2012 (c) cash refunds can be made only for cash/check payments that were made. Monies paid from fundraising may not be refunded as cash.

_____ I understand that if we have any outstanding band fees due (i.e. – marching band activity fee, uniform cleaning fee, show shirts, etc.) or if we have unpaid fees carried over from last year that we can not be added to the trip until those fees are paid for.

_____ I understand that trip payments MUST be made according to the payment schedule. Failing to make a payment on time may result in our name being removed from the trip list.

Yes, I have read and understand everything above. I accept all the above stated conditions for my child's participation in this activity and will ensure my child's understanding of them.
